

AMERICAN SADDLEBRED REGISTRY 2009 FUTURITY OF KENTUCKY

GENERAL PROVISIONS

**DIVISIONS AND HOW SHOWN** – The American Saddlebred Registry Futurity of Kentucky will be held each year in three divisions: WEANLINGS and YEARLINGS shown IN HAND, and TWO-YEAR-OLDS shown in FINE HARNESS. The classes are held at the Kentucky State Fair and are conducted under the rules of the U.S. Equestrian Federation. See the specific rules for the IN HAND division, U.S. Equestrian Federation Rule Book, or refer to the Kentucky State Fair prize list.

**DECLARATION OF INTENT TO SHOW** – A signed Declaration of Intent to Show and a \$50.00 starting fee payment for each entry must be made to the American Saddlebred Registry Futurity Secretary by the deadline date as determined for such payment. All starting fees will be added to the purse for the appropriate class.

**NO ENTRY WILL BE ALLOWED TO SHOW UNLESS THE DECLARATION OF INTENT TO SHOW HAS BEEN FILED AND THE FEE PAID BY THE DEADLINE.**

**DIVISION OF IN HAND CLASSES** – Any class in the IN HAND division with 41 or more declared entries shall be divided as equally as possible into two sections. When a class has been divided, the division of entries will be posted in the horse show office and also announced. No more than 12 entries from the sections shall be selected by the judges to return for a final class to be held at a morning, afternoon or evening performance, at least two days following the preliminary sections. All prize money will be awarded in the final class.

**DIVISION OF FINE HARNESS CLASS** – The TWO-YEAR-OLD FINE HARNESS class shall be divided as equally as possible into two sections, if 16 or more declarations and fee payments have been filed with the American Saddlebred Registry Futurity Secretary by the deadline date. When the class has been divided, the division of entries will be posted in the horse show office and also announced. No more than 15 entries will be selected from both sections to show in a final class to be held at a morning, afternoon or evening performance, at least two days following the preliminary sections. All prize money will be awarded in the final class.

**SHOWING PROCEDURE FOR IN HAND ENTRIES** – Entries will enter the ring one at a time showing at a trot, be led down the right-hand rail to the other end of the ring, return to the judges at a trot, and then be judged on conformation. On the return lead, entries are permitted to trot past the judges to the end of the ring, if so desired, and then return to the judges. Entry will then be led to the opposite rail at a walk, out of the way of subsequent entries. A second workout is strongly encouraged in a large class at the judges discretion. If judged on conformation a second time, entries must again be led at a walk and trot. Entries are not to be judged lunging. A diagram will be posted in the horse show office. **NOTE:** Pursuant to U.S. Equestrian Federation: Conformation and finish count 50% of the total score. All entries should be judged according to the standards for the ideal American Saddlebred type and conformation. Defects **must** be penalized.

**PLEASE NOTE THE FOLLOWING CHANGE TO THE JUDGING SPECIFICATIONS FOR TWO-YEAR-OLD FINE HARNESS ENTRIES. This change was effective March 1, 2004.**

**SHOWING PROCEDURE FOR TWO-YEAR-OLD FINE HARNESS ENTRIES:** Pursuant to U.S. Equestrian Federation Rule: Exhibited at an animated walk; park trot (speed to be penalized) and "show your horse," to stand quietly. ***Judged on performance, conformation, presence, quality, and manners.***

**ELIGIBILITY** – All horses shown must be the produce of stallions and mares that have been nominated to the American Saddlebred Registry Futurity of Kentucky. Any nomination described in these rules may be made by the stallion owner, the mare owner, the owner of the foal, or their authorized agents. IT IS THE RESPONSIBILITY OF THE MARE NOMINATOR TO DETERMINE WHETHER THE SIRE OF THE FOAL HAS BEEN PROPERLY NOMINATED.

**SIRE NOMINATION** – To nominate a stallion to the American Saddlebred Registry Futurity of Kentucky, it is necessary:

- 1) That the stallion be registered with the American Saddlebred Registry, the ASHA of Canada or any foreign registry approved by ASR. If registered with the ASHA of Canada or an approved foreign registry, a copy of the stallion's registration certificate must be submitted with the nomination.
- 2) That a fee of \$100.00 be paid to the American Saddlebred Registry Futurity of Kentucky on or before April 15 each year a foal is born; however, a stallion nomination will be accepted if the fee is received in the American Saddlebred Registry office no later than the close of business on May 15 of such year.

**DAM NOMINATION** – To nominate a mare to the American Saddlebred Registry Futurity of Kentucky, it is necessary:

- 1) That the mare be registered with the American Saddlebred Registry, the ASHA of Canada or any foreign registry approved by ASR. If registered with the ASHA of Canada or an approved foreign registry, a copy of the mare's registration certificate must be submitted with the nomination.
- 2) That a fee of \$25.00 be paid to the American Saddlebred Registry Futurity of Kentucky on or before April 15 each year a foal is born.

**NOTE: In the year of nomination, the donor mare must be nominated for each foal/embryo that she will produce that year. A \$25.00 dam nomination fee, per foal/embryo, will be due April 15.**

**WEANLING ELIGIBILITY** – To keep a weanling eligible to show in the American Saddlebred Registry Futurity of Kentucky, the following conditions must be fulfilled:

- 1) The sire and dam must be nominated to the American Saddlebred Registry Futurity of Kentucky by April 15 of the year in which the foal is born.
- 2) A weanling fee of \$50.00 must be paid to the American Saddlebred Registry Futurity of Kentucky on or before June 15 of the year the foal is born.  
**NOTE: A weanling fee of \$50.00 must be paid for each foal/embryo produced by a nominated donor mare in order to maintain eligibility for any of the foals/embryos.**
- 3) Due to the extremely high number of futurity foal applications received in previous years either the day before or the actual date when a conditional registration number is required to be eligible to show, foals showing in the Kentucky & Kentucky Amateur Futurity Weanling Divisions must have applications for registration received in the American Saddlebred Registry office on June 25, or, in the event this date falls on a Saturday or Sunday, by 4:30 p.m. Eastern Time on the following business day. **NO EXCEPTIONS.** A rush fee of \$50 will be assessed for any such applications received June 26 or thereafter. Such fee will be billed to the applicant and will be due and payable immediately. **HOWEVER, ALL WEANLINGS MUST BE BLOOD TYPED OR DNA TESTED PRIOR TO SHOWING IN THE AMERICAN SADDLEBRED REGISTRY FUTURITY OF KENTUCKY, I.E., PENDING/CONDITIONAL APPLICATIONS MUST BE COMPLETED.**
- 4) If not shown as a weanling, the foal must be registered (or application received in the American Saddlebred Registry office) by December 31 of the foaling year.  
**Pending applications (including DNA testing) must be completed before March 31 of the yearling year.**

**YEARLING ELIGIBILITY** – To keep a yearling eligible to show in the American Saddlebred Registry Futurity of Kentucky, the following conditions must be fulfilled:

- 1) The horse must have been nominated as a weanling, and all conditions and requirements must have been fulfilled.
- 2) ONE yearling payment (\$50.00 if received by January 31 OR \$75.00 if received after January 31 and prior to April 15 of the year the foal becomes a yearling) must be paid to the American Saddlebred Registry Futurity of Kentucky.
- 3) **At the time of the January 31 yearling payment, the owner of any foal produced from a nominated mare with multiple foals must declare whether such owner's foal/embryo is to be kept eligible.**

## AMERICAN SADDLEBRED REGISTRY 2009 FUTURITY OF KENTUCKY

**TWO-YEAR-OLD ELIGIBILITY** – To keep a two-year-old eligible to show in the American Saddlebred Registry Futurity of Kentucky, the following conditions must be fulfilled:

- 1) The horse must have been nominated as a weanling, and all conditions and requirements for a weanling and yearling must have been fulfilled.
- 2) ONE two-year-old payment (\$50.00 if received by January 31 OR \$100.00 if received after January 31 and prior to April 15 of the year the foal becomes a two-year-old) must be paid to the American Saddlebred Registry Futurity of Kentucky.

**REGISTRATION** – All horses must be registered (or application received in the American Saddlebred Registry office) by December 31 of the foaling year in order to maintain eligibility. **To continue eligibility, pending applications must be completed before March 31 of the yearling year, i.e., results of blood typing or DNA testing must be received in the American Saddlebred Registry office before March 31.**

Due to the extremely high number of futurity foal applications received in previous years either the day before or the actual date when a conditional registration number is required to be eligible to show, foals showing in the Kentucky & Kentucky Amateur Futurity Weanling Divisions must have applications for registration received in the American Saddlebred Registry office on June 25, or, in the event this date falls on a Saturday or Sunday, by 4:30 p.m. Eastern Time on the following business day. **NO EXCEPTIONS.** A rush fee of \$50 will be assessed for any such applications received June 26 or thereafter. Such fee will be billed to the applicant and will be due and payable immediately. **HOWEVER, A WEANLING MUST BE REGISTERED – RESULTS OF BLOOD TYPING OR DNA TESTING MUST BE IN THE AMERICAN SADDLEBRED REGISTRY OFFICE – PRIOR TO SHOWING IN THE AMERICAN SADDLEBRED REGISTRY FUTURITY OF KENTUCKY.**

**KENTUCKY STATE FAIR ELIGIBILITY** – All horses, INCLUDING AMERICAN SADDLEBRED REGISTRY FUTURITY ENTRIES, must be entered properly on printed forms furnished by the Kentucky State Fair. Prize lists, which include entry forms, will be mailed in early May. **PRIZE FUND** – The value of the prize fund of the American Saddlebred Registry Futurity of Kentucky each year shall be the total amount of money paid in fees, miscellaneous funds, added donations, and interest, less administrative costs.

### ***Distribution of Prize Money — SIRE/DAM PURSES:***

**In the 2009 weanling class**, \$5.00 received from each April 15 mare nomination fee paid will be put into a purse to be paid to the owners (at the time of the original nomination) of the sires and dams of the first and second place weanlings, as follows: 1st, one-third; 2nd, one-sixth.

**In 2010**, \$5.00 received from each January 31 yearling fee paid will be put into a purse to be paid to the owners (at the time of original nomination) of the sires and dams of the first and second place yearlings, as follows: 1st, one-third; 2nd, one-sixth.

**In 2011**, \$5.00 received from each January 31 two-year-old fee paid will be put into a purse to be paid to the owners (at the time of original nomination) of the sires and dams of the first and second place two-year-olds, as follows: 1st, one-third; 2nd, one-sixth.

NOTE: If the owner (or owner's agent) of the sire or dam at the time of original nomination did not pay the sire or dam nomination fee, any sire or dam prize money shall go to the person who actually paid the original nomination fee.

### ***Distribution of Prize Money – OWNER PURSES:***

The remaining prize money is paid to the owners of the winning entries at the time of the Futurity and is divided equally among the weanling, yearling and two-year-old divisions. In the case of a leased horse, written authorization from the current owner will be required to release the prize money to the lessee. In each division, each winner will receive 50% of the prize fund for that division; 2nd, 25%; 3rd, 12.5%; 4th, 7.5%; 5th, 3%; and 6th, 2%.

Should there be fewer than six entries showing, the entries that do show will share the remainder of the prize fund in the same proportion designated to the place they have won. The total prize fund each year will be paid out, regardless of the number shown. American Saddlebred Registry reserves the right to cancel a class if there are no entries. If a class is cancelled, the prize fund will be redistributed among the classes that do show.

**U.S. EQUESTRIAN FEDERATION DRUG TESTING** – All American Saddlebred Registry futurity classes are subject to U.S. Equestrian Federation drug-testing procedures. See U.S. Equestrian Federation Chapter 4, GR401-GR413 governing "Drugs & Medications." Markings verification of all ribbon winners will be required. If an entry has been disqualified by American Saddlebred Registry, U.S. Equestrian Federation or the horse show where the horse has competed, the owner shall forfeit and return all premium money, trophies and ribbons upon notification.

**An IRS form 1099 will be sent to all money winners.**

**PAYMENT OF FEES** – Payments can be made by check, money order, Visa or MasterCard. A \$25.00 service charge will be assessed on any returned checks and added to the total due. All payments must be made to the American Saddlebred Registry Futurity and mailed to 4083 Iron Works Parkway, Lexington, Kentucky 40511, or faxed to 859/259-1628, on or before the dates herein specified, or bear U.S. postmark before midnight of such dates. In the event a closing date falls on a Sunday or legal holiday, postmark bearing the date of the following day will be accepted.

**NOTE: U.S. Postal Service postmark supersedes a postage meter date.**

**GRACE PERIOD – TEN CALENDAR DAYS AFTER PAYMENT DUE DATE.**

**LIABILITY** – No entry is liable for more than the amount paid in, but there will be no return of payment. The right is reserved to reject any entry and bar any entry from competition for failure to comply with the conditions of this futurity.

**IF A PREVIOUSLY NOMINATED HORSE IS SOLD, IT IS THE SELLER'S RESPONSIBILITY TO NOTIFY THE NEW OWNER OF PAYMENT DUE DATES.**

**NOTICE** – AGENTS AND/OR OWNERS MAKING ENTRY IN THIS FUTURITY ARE RESPONSIBLE FOR MAKING PAYMENTS WHEN DUE. **THE AMERICAN SADDLEBRED REGISTRY FUTURITY OF KENTUCKY ASSUMES NO RESPONSIBILITY FOR REMINDING PARTICIPANTS OF PAYMENT DATES.**

For future reference, keep a copy of all nominations and rules.

ALL OWNERS/TRAINERS PARTICIPATING AT THE 2009 KSF WORLD'S CHAMPIONSHIP HORSE SHOW  
(INCLUDING AMERICAN SADDLEBRED REGISTRY FUTURITIES) MUST BE MEMBERS OF ASHA.**
