

# NOTICE OF LEASE AGREEMENT

For a lease of a horse to be recognized by the Registry, written notice of its existence must be filed with the Registry within thirty (30) days of its execution, signed by both lessor and lessee, with all applicable fees. The notice must provide the effective date of lease and may provide a termination date. Otherwise, it may be terminated by written notice, giving termination date, signed by both lessor and lessee or by a properly executed transfer which shows a change of ownership from lessor to lessee. The notice must identify the horse to which the lease is applicable.

1. Checking the box marked "Breeding" in the Purpose of Notice section below, authorizes lessee to execute all documents pertaining to the recognized activities of breeding, regardless of any limitation in the actual lease agreement. **Enforcement against the lessee of limitation on use of the horse is solely the responsibility of the lessor.**
2. During the effective term of the lease, the Registry will not record subsequent changes in ownership until the lease is terminated.
3. Membership in the American Saddlebred Horse Association is required to transact business with the American Saddlebred Registry.
