- Attendace to the Clinics fulfills the clinic maintenance requirements for officials to renew their license(s).
*Applicants must start their checklists through their USEF Accounts **after** attending the clinic and receiving a favorable score from the clinicians.
- Please have access to the USEF Rulebook via your phone, tablet, laptop or hardcopy printout you bring with you to the clinic.
- USEF Maintenance Exams are no longer administered as part of the clinics. USEF will contact you via e-mail when you are due to take your test through their online testing site.
- The schedule of clinics (Morgan, Saddlebred, Hackney, Roadster, and Saddle Seat Equitation) has specifically been designed so that judges that hold multiple cards can attend all the sessions and receive credit. However, licensed judges that also wish to attend the Morgan session must register separately through AMHA and pay the applicable fees.
