2. Results must be submitted to ASHBA within ten (10) days of the last day of the competition and received in the ASHBA results template.
3. Results should include the complete class listing and all names of horses with American Saddlebred and Half Saddlebred registration numbers shown and judged, not just ribbon winners. Include names and ASHBA membership numbers for all owners, riders, drivers, handlers and trainers.
4. USEF Saddlebred and Half Saddlebred Breed Rules must be followed and these rules supersede all other rules.
5. Shows must enforce USEF and US Center for Safe Sport Ineligibility Lists. Safe Sport training required at USEF Licensed Competitions.
6. Shows must include ASHBA as an additional insured on Certificate of Liability Insurance and send a copy to ASHBA prior to the first date of the show.
