Name claim submitted after February 1 of the foal's two-year-old year	<b>\$250.00</b>

Owners of unnamed "registered" horses will be required to submit a Name Claim form along with a Name Claim fee before the Certificate of Registration will be issued. Registration certificates will only be issued for those horses that have officially claimed names. The Registry of the ASHBA will not record any further transactions concerning an unnamed animal until a name has been officially claimed.

### ASHBA FUTURITY AND SWEEPSTAKES RULES PERTAINING TO NAME CLAIMING

**ASHBA FUTURITY RULES** - To continue eligibility, pending applications must be completed before March 31 of the yearling year, i.e., a registration number assigned and results of DNA testing must be received in the ASHBA office before March 31. Weanlings must be DNA tested and have a name claimed prior to showing. **A name must be claimed 30 days prior to the horse show entry closing deadline. A Rush Fee of \$100.00 will be assessed if a name is not claimed 30 days prior to the horse show entry closing deadline. Effective 2019 foal crop.**

### ASHBA SWEEPSTAKES RULES

**Two-Year-Old Sweepstakes:** Open to American Saddlebred yearlings that have been assigned a registration number and DNA testing results completed with the Registry of the ASHBA before the nomination closing date of June 1 of the horse's yearling year. **A name must be claimed 30 days prior to the horse show entry closing deadline. A Rush Fee of \$100.00 will be assessed if a name is not claimed 30 days prior to the horse show entry closing deadline. Effective 2019 foal crop.**

**Three-Year-Old Sweepstakes:** Open to American Saddlebred yearlings that have been assigned a registration number and DNA testing results completed with the Registry of the ASHBA (or application received in the ASHBA office) before the nomination closing date of March 1 of the horse's yearling year. "In order to maintain sweepstakes eligibility, pending applications, including a registration number assigned and DNA testing results must be completed prior to March 31 of the yearling year. **A name must be claimed 30 days prior to the horse show entry closing deadline. A Rush Fee of \$100.00 will be assessed if a name is not claimed 30 days prior to the horse show entry closing deadline. Effective 2019 foal crop.**
