\$100,000 BREEDERS CHALLENGE STAKE



Eligibility for the class: An online auction is held during the week of the World's Championship Horse Show. All of the winning bidders, along with the owners of the donated stallion services that obtain at least \$750 will get a voucher to compete in the following year's \$100,000 Breeders Challenge Stake class. The vouchers are not transferable, but a horse that has been sold after being declared for the Breeders Challenge class can still show in that class under the new ownership, provided a horse voucher assignment form has been completed by the seller. You are allowed to purchase multiple stallion services to have the opportunity to show multiple horses in the class. If a stallion owner purchases their own stallion service back they will get two vouchers, one for donating their stallion service and one for purchasing a stallion service. Vouchers are not transferable from year to year and must be used in the class that follows the stallion service auction.

Prize Money: If more than the allowable number of horses are entered in the class, there will be qualifiers set up similar to the current prize program qualifiers. The qualifying classes will not be tied and the judges will choose which horses make it back to the championship class. Prize money is divided among pinnings 1st through 10th.

How are they shown: Four-Year-Olds to be shown Three-Gaited, trimmed or full mane.

Where are they shown: World's Championship Horse Show, Louisville, KY.

ASHBA TWO-, THREE- AND FOUR-YEAR-OLD SWEEPSTAKES

TWO-YEAR-OLD SWEEPSTAKES Nomination requirements: No sire, dam, or weanling nominations required. Nominations must begin with the yearling year and all conditions and requirements for the yearling and two-year-old years must have been fulfilled.

- **Payments:** \$75 due June 1 of the horse's yearling year **OR** \$125 due September 15 of the horse's yearling year **AND** \$200 due June 1 of the horse's two-year-old year.

THREE-YEAR-OLD SWEEPSTAKES Nomination requirements: No sire, dam, or weanling nominations required. Nominations must begin with the yearling year and all conditions and requirements for the yearling, two-year-old and three-year-old years must have been fulfilled.

- **Payments:** \$500 due March 1 of the horse's yearling year **OR** \$200 due March 1 of the horse's yearling year **AND** \$200 due March 1 of the horse's two-year-old year **AND** \$200 due March 1 of the horse's three-year-old year.

FOUR-YEAR-OLD SWEEPSTAKES Nomination requirements: No sire, dam, weanling, yearling or two-year-old nominations required. Nominations must begin with the three-year-old year and all conditions and requirements for the three-year-old and four-year-old years must have been fulfilled.

- **Payments:** \$500 due March 1 of the horse's three-year-old year **OR** \$250 due March 1 of the horse's three-year-old year **AND** \$250 due March 1 of the horse's four-year-old year.

Prize Money: Prize money is divided between the recorded owner at the time of competition and the nominator(s).

How are they shown: Shown as two-year-olds in Fine Harness and Three-Gaited Park. Shown as three- and four-year-olds in Three-Gaited, Five-Gaited, Fine Harness, and Three-Gaited Park Pleasure (professional may ride).

ASHBA NATIONAL FUTURITY



Nomination requirements: Nominations must begin in the foaling year and all conditions and requirements for the weanling, yearling, two-year-old, and three-year-old years must have been fulfilled. All payments must be made to maintain eligibility. Futurity ends after three-year-old year.

Payment Schedule:

Foaling Year – March 31 \$150
Yearling Year – January 31 \$150
Two-Year-Old Year – January 31 \$150
Three-Year-Old Year – January 31 \$150

Who's eligible to show: Weanlings, yearlings, two-year-olds, and three-year-olds.

How are they shown: Weanlings & yearlings In-Hand, two-year-olds in Fine Harness or Three-Gaited, three-year-olds in one of five classes: Three-Gaited, Five-Gaited, Fine Harness, Three-Gaited Park, and Three-Gaited Park Pleasure (professional may ride). Foals are not required to be shown to maintain eligibility.

Where are they shown: World's Championship Horse Show, Louisville, KY.

ASHBA NATIONAL AMATEUR FUTURITY

Nomination requirements: Nominations must begin in the foaling year and all conditions and requirements for the weanling, yearling, two-year-old and three-year-old years must have been fulfilled. All payments must be made to maintain eligibility. Futurity ends after three-year-old year.

Payment Schedule:

Foaling Year – March 31 \$150
Yearling Year – January 31 \$150
Two-Year-Old Year – January 31 \$150
Three-Year-Old Year – January 31 \$150

Who's eligible to show: Weanlings, yearlings, two-year-olds, and three-year-olds.

How are they shown: Weanlings, yearlings and two-year-olds In-Hand, three-year-olds in Three-Gaited Park Pleasure (amateur must ride). Foals are not required to be shown to maintain eligibility.

Where are they shown: World's Championship Horse Show, Louisville, KY.



ASHBA HALF SADDLEBRED WEANLING FUTURITY



Nomination requirements: Nominations in the foaling year only. Futurity ends after the weanling year.

Payment Schedule:

Foaling year – April 30 \$150

Who's eligible to show: Half-Saddlebred weanlings registered with ASHBA.

How are they shown: Weanlings In-Hand.

Where are they shown: All American Horse Classic, Indianapolis, IN.
