2024 Weanling Nomination: A fee of \$150.00 must be paid on or before May 1 of the foaling year.

A \$150 nomination fee, for each foal/embryo born, will be due May 1. In the event a mare foals, producing twins, after the nomination deadline, the owner must notify the ASHBA Registry within 30 days of foaling to nominate and pay the nomination fee for the second foal. However, one foal must have been nominated by the original deadline.
